- Special Operations Division Chief Tim Perkins. Oversees Air Ops, Wildland Operations, USAR Program, the Technical Rescue Program, Hazmat program; and Investigations;
- Division Chief Baryic Hunter oversees Community Volunteer Services including Training, Reserves and Cadets Programs, and the Chaplain Program;
- Division Chief Jim Henery oversees fire stations in Santa Ana and working with recruitment for the academies and promotions.
