B. Fiscal Year 2021/22 Backfill/Overtime and Calendar Year 2022 Total Earnings/Compensation Analysis (FILE 15.11)

Chris Hamm, President of Firefighters Local 3631, commended the OCFA Executive Team for its plan to reduce forced overtime.

Assistant Chief Cortez presented the Fiscal Year 2021/22 Backfill/Overtime and Calendar Year 2022 Total Earnings/Compensation Analysis.

On motion of Director Hernandez and second by Director Rossini, and following vote by acclamation approved 6-0 (Directors Bourne, Gabbard, and Nguyen absent) to review the proposed agenda item and direct staff to place the item on the agenda for the Board of Directors meeting of April 27, 2023, with the Budget and Finance Committee's recommendation that the Board of Directors take the following actions:

1. Direct staff to continue pursuing reductions in overtime by filling vacant positions as quickly as possible after the positions become vacant.

2. Authorize staff to temporarily exceed the number of authorized dispatcher positions on the Master Position Control to maximize the number of dispatchers hired into each academy, pending attrition/retirements/promotions that will occur.
3. Direct staff to continue using overtime to fill shifts which are temporarily vacant rather than hiring additional personnel, recognizing this as a cost-effective practice for temporary needs.
