#### REPORT FROM THE BUDGET AND FINANCE COMMITTEE CHAIR (F:11.12)

Budget and Finance Committee Chair McCloskey reported at its October 14, 2015, the Committee voted unanimously to direct staff to place the Fourth Quarter Financial Newsletter and the Monthly Investment Report on the agenda for the Executive Committee meeting with the Budget and Finance Committee's recommendations that the Executive Committee receive and file the reports. The Budget and Finance Committee also voted unanimously to direct staff to place the Quarterly Change Order Report and the Replacements for Broker/Dealer List on the agenda for the Executive Committee meeting, with the Budget and Finance Committee's recommendations that the Executive Committee approve the recommended actions. Lastly, the Budget and Finance Committee voted unanimously to receive and file the report on the Quarterly Status Update Orange County Employees' Retirement System.

Human Resources Committee Chair Shawver reported the Human Resources Committee did not meet in the month of October; therefore there is nothing to report at this time.

#### REPORT FROM THE CLAIMS SETTLEMENT COMMITTEE CHAIR (F: 11.12)

Claims Settlement Committee Chair Hernandez stated the Claims Settlement Committee considered a workers' compensation claim for claimants Duran Swanson and Terry Carson, and there was no reportable action.

#### **REPORT FROM THE FIRE CHIEF** (F: 11.14)

Fire Chief Jeff Bowman reported he recently met with and provided both the Board Chair and Vice Chair written and verbal updates to his objectives and initiatives, and he will provide the full Board with a semi-annual update in January. He reported on his attendance at a statewide meeting on fire issues, that a majority of the California wildfires are fully contained, the Orange County Fire Chief's Association consideration of a CAD-to-CAD device and countywide AVL system. Fire Chief Bowman also commended Division Chief Anderson and Assistant Chief Schroeder for their work in attaining additional savings of \$50,000 for the existing CAD system work list. Fire Chief Bowman introduced Clerk of the Authority Sherry Wentz, who reminded the meeting attendees of the on-going sale of pink tee shirts for Breast Cancer Awareness month.

## B. Amendment to Advanced Life Support Billing/Reimbursement Agreements (F: 18.05A4)

Assistant Chief Lori Zeller presented the amendment to Advanced Life Support/Billing Reimbursement Agreements.

Stephen Wontrobski, Mission Viejo resident, spoke in opposition to ALS rebates.

On motion of Director Murray and second by Director Shawver, the Board of Directors voted by those present to:

- 1. Approve and authorize the Board Chair to sign an Amendment to the Advanced Life Support Services Billing Agreement in the form provided, to temporarily suspend any increases in the OCFA's Reimbursement Rates for twelve months.
- 2. Direct staff to request that the County CEO remove the Advance Life Support billing and reimbursement rates from the October 27, 2015, Board of Supervisor's agenda or subsequent agenda for one year. Director Spitzer abstained on Recommended Action No. 2 since this item would be forthcoming to the Board of Supervisors.

Directors Lalloway and Ta were absent for the vote.

#### **BOARD MEMBER COMMENTS** (F: 11.13)

Director Goedhart introduced audience attendee La Palma City Council Member Michele Steggell.

Director Sachs commended Orange County Sheriff's and OCFA investigators for the apprehension of an arsonist in Mission Viejo.

Director Gamble noted OCFA had been offered \$1 million over its purchase price for the US&R building, and praised Battalion Chief Bryan Brice for his diligence on the original negotiated purchase price.

Director Murray thanked OCFA members involved in the annual Orange County Firefighters Memorial, and reminded everyone to buy a pink tee shirt to support Breast Cancer Awareness month.

Director McCloskey reported attending both Laguna Niguel and Aliso Viejo Fire Station's Open Houses.

Director Shawver praised those involved in the OC Firefighter Memorial service, and noted his attendance at Stanton's Fire Station 46's Open House.

Director Hatch reported attending the League of California Cities conference.

Director Johnson attended the Open House at Station 17, and thanked Captain O'Brien for his work on the event.

Director Barnett introduced the "Home Hospitality Program" a coordinated event between Villa Park and Camp Pendleton to sponsor and invite a Marine home for Thanksgiving.

Director Green thanked the firefighters from Stations 34 and 35 for their assistance at Placentia's Heritage Festival.

Chair Hernandez reported on his attendance at the OC Firefighters Memorial event, and reminded everyone of the upcoming Open House at OCFA on October 24.
