B. Thank you from Workmeister Family to OCFA Staff and Board (F: 11.09)

Assistant Chief Mike Schroeder presented a PowerPoint presentation regarding a tragic accident that resulted in life threatening injuries to father and son. The Workmeister family gave special thanks to the crew of Fire Station 54 (Lake Forest), Paramedic John Paul O'Hara, and the OCFA Board of Directors for the family member's survival.

Stephen Wontrobski, Mission Viejo resident, spoke in opposition to State Senate Bill 302 and addressed OCFA member city's cost for services.

Dave Lopez, Seal Beach resident, spoke in opposition to the Orange County Sheriff's Department's failure to abide by and intent to terminate the existing memorandum of understanding concerning air operations between the two agencies.

Human Resources Chair Noel Hatch reported at the July 11, 2017, meeting the Committee received and filed the Quarterly Human Resources Accomplishment/Project Update, Recruiting Program and Promotional Process Updates, reviewed and voted unanimously to send the New/Revised Classification Specifications for Human Resources Specialists and Analyst Services to the Executive Committee for its approval, and also to send both the Master Position Control Revision for Human Resources Manager, and the Master Position Control Revision for Emergency Command Center Positions to the Board of Directors for their approval.

Fire Chief Bowman provided the FY 2016/17 Performance Update. He introduced Assistant Chief Dave Anderson who introduced newly hired Emergency Command Center Manager Jeff Logan and provided a brief overview of the formation of the Technology Task Force noting that Director Murray will serve as its Chair. Assistant Chief Lori Smith introduced Battalion Chief Brian Norton who provided a PowerPoint informational presentation on the Gold Spotted Oak Borer and its impact on the environment. Assistant Chief Lori Smith also provided a brief report on the outcome of the 4th of July. Assistant Chief Brian Young provided a status of California wildland fires.

Director Farias arrived at this point (6:57 p.m.).

Director Muller addressed a recent fire that occurred at the Doubletree Hotel and commended the crew of Fire Station 29 (Dana Point) for its firefighting efforts.

Director Spitzer arrived at this point (7:01 p.m.).

On motion of Director Johnson and second by Director Davies, the Board of Directors voted unanimously by those present to approve the proposed annual proclamation.

B. County-wide Community Wildfire Protection Plan (F: 16.02I)

On motion of Director Johnson and second by Director Davies, the Board of Directors voted unanimously by those present to:

- 1. Find that the proposed project is Statutorily Exempt from the provisions of CEQA as a feasibility and planning study pursuant to Section 15262 of the CEQA Guidelines.
- 2. Approve the County-wide Community Wildfire Protection Plan for Orange County.

C. Emergency Command Center Trial Program for Communications Training Officer (F: 17.12)

On motion of Director Johnson and second by Director Davies, the Board of Directors voted unanimously by those present to:

- 1. Establish a 15% specialty compensation for Fire Communications Dispatchers selected to act as Communications Training Officers in Dispatcher Academy #13.
- 2. Increase appropriations in the FY 2017/18 General Fund (121) Budget by \$97,632 to fund the specialty compensation.

D. Master Position Control Revision for Emergency Command Center Positions (F: 17.12) (X: 18.0)

On motion of Director Johnson and second by Director Davies, the Board of Directors voted unanimously by those present to:

- 1. Approve freezing one Senior Fire Communications Supervisor position on the Master Position Control.
- 2. Approve converting three part-time Fire Communications Dispatcher positions to fulltime on the Master Position Control.
- 3. Approve a budget adjustment decreasing appropriations in the FY 2017/18 General Fund (121) Budget by \$27,457.

E. Master Position Control Revision for Human Resources Manager (F: 17.12) (X: 17.10)

On motion of Director Johnson and second by Director Davies, the Board of Directors voted unanimously by those present to:

- 1. Approve the addition of one Human Resources Manager position to the Master Position Control in order to reduce OCFA exposure to personnel-related liabilities and inefficiencies.
- 2. Approve a budget adjustment increasing appropriations in the FY 2017/18 General Fund (121) Budget by \$253,681 (salary and benefits) to fund the additional Human Resources Manager.

F. Master Position Control Revision for Urban Search and Rescue Positions (F: 17.12) (X: 22.05)

On motion of Director Johnson and second by Director Davies, the Board of Directors voted unanimously by those present approve adding two part-time Limited-Term Fire Equipment Technicians to the Master Position Control list. These positions replace the use of Extra Help personnel and will be funded through the Urban Search and Rescue grant funds received from the Federal Emergency Management Agency.

G. Acceptance of Funds from the 2016 Homeland Security Grant Program for an Administrative Fire Captain Assigned to the Orange County Intelligence Assessment Center (F: 16.02A1)

On motion of Director Johnson and second by Director Davies, the Board of Directors voted unanimously by those present to:

- 1. Approve the FY 2016 Homeland Security Grant Program Agreement and authorize the Fire Chief to execute it and any necessary attachments and agreement(s) to accept and administer the Urban Area Security Initiative Grant.
- 2. Approve a Budget Adjustment in Fund 121 to increase revenue and appropriations by \$160,000 for the FY 2016 Homeland Security Grant Program award.

- 2. Increase appropriations in the FY 2017/18 General Fund (121) Budget by \$345,191 to fund the difference between current budgeted overtime pay and regular salary and benefit costs for these converted positions.
- 3. Authorize staff to temporarily exceed the number of authorized firefighter positions on the Master Position Control to enable the hiring of 50 firefighters into each of the next two academies. This temporary authorization shall only apply to the next two academies (45 and 46), pending attrition/promotions that will occur during and following academy graduations.

To continue provision of fire protection services to State Responsibility Areas, it is recommended that the Board approve and authorize the Board Chair to sign the Assignment of three-year Cooperative Fire Protection Agreement between the State of California Department of Forestry and Fire Protection and the County of Orange to OCFA.

Background

The State, through CAL FIRE, is responsible for fire protection services in State Responsibility Areas (SRAs) in Orange County. Those SRAs are generally unincorporated wildland open space.

Since 1980, the State has contracted to pay the County to perform those services. Since the formation of the OCFA, it has been necessary to have a tri-party agreement among the County, CAL FIRE, and OCFA that allows the OCFA to continue providing CAL FIRE services in the SRA. This three-year agreement begins July 1, 2017, and will terminate on June 30, 2020, and will continue to provide the ability to bill CAL FIRE for OCFA-owned aircraft, fire engines, specialized equipment, and handcrews deployed on SRA fires.

The delay in the renewal of the agreement was due to the CAL FIRE labor negotiation process, which needed to be completed prior to the issuance of a new agreement. There is no disruption in service due to a 1-year service grace period that was included in the prior contract.

In addition, this agreement provides the OCFA the ability to seek reimbursement from other agencies for fire suppression resources provided on an assistance-for-hire basis.

The Orange County Board of Supervisors approved the agreements at its August 22, 2017, meeting.

1. Contract agreement between California Department of Forestry and Fire Protection (CAL FIRE) and County of Orange/Assignee Orange County Fire Authority to provide services as described herein:

The terms and conditions of this agreement have been previously reviewed and approved by the Department of General Services (DGS) during prior agreement reformats and rewrites. The completed agreement signed by CAL FIRE (STATE) and County of Orange/Assignee Orange County Fire Authority (COUNTY) provides wildland fire protection to State Responsibility Area (SRA) lands within COUNTY pursuant to Public Resources Code (PRC) Section 4129. Agreement also provides for COUNTY to assist STATE outside of COUNTY on a reimbursable basis when requested by STATE. Agreement contains a hold over clause for time required to obtain agency review and approvals.

- 2. The services shall be performed at SRA within the County.
- 3. The services shall be provided during any 24 hour period, Monday through Sunday, year round.

This AGREEMENT, made between the County of Orange, through its Board of Supervisors, hereinafter called COUNTY, and the State of California, Department of Forestry and Fire Protection (CAL FIRE), through duly appointed, qualified, and acting officers, hereinafter called STATE. Where the standard clauses, for example in Exhibit C, use the word "Contractor" that word shall mean COUNTY as COUNTY is used in this agreement.

The STATE and the COUNTY agree that the background of this Agreement is as follows:

- A. There are within COUNTY areas designated by the State Board of Forestry and Fire Protection as State Responsibility Areas for fire protection through authority vested in STATE by Section 4125, of the Public Resources Code.
- B. STATE, under authority of Public Resources Code Section 4141, may assign responsibility to a Federal Forest Agency within COUNTY for the prevention and suppression of all fires on State Responsibility Areas within Federal Forest Agency's Direct Protection Areas.
- C. Designated State Responsibility Areas in Federal Forest Agency's Direct Protection Areas are delineated on maps on file with STATE in Sacramento, California.
- D. COUNTY, by authority of Public Resources Code Section 4129, has elected to assume responsibility for the prevention and suppression of all fires on State Responsibility Areas (SRA) within COUNTY'S SRA Protection Areas (CPA).
- E. Designated State Responsibility Areas in COUNTY'S SRA Protection Areas are delineated on maps on file with STATE in Sacramento, California.
- F. STATE recognizes the capability and efficiency of the COUNTY fire protection organization now maintained by the COUNTY and its qualification to provide the fire protection services described within this agreement.
- G. COUNTY has the responsibility for providing life and property fire protection in areas designated as State Responsibility Areas within COUNTY SRA Protection Areas.
- H. Under the Budget Act, and in accordance with the STATE'S Fire Protection Plan, there is annually appropriated to CAL FIRE, funding for wildland fire protection in said COUNTY.
- I. Under the authority of Section 4135, of the Public Resources Code, monies paid by STATE to COUNTY shall be expended by COUNTY for the sole purpose to fund the fire suppression resources outlined in the "Gray Book", incorporated by reference and marked Exhibit F, of this Agreement, for fire prevention, pre-suppression forces preparedness, and suppression of all fires on State Responsibility Areas within COUNTY'S SRA Protection Areas; and

EXHIBIT A, Attachment 2 (Detailed Scope of Work)

1. State and County Responsibilities

The STATE and the COUNTY agree that the following work shall be done under this agreement:

- A. STATE shall supply to COUNTY, the "Gray Book", which outlines and describes the organization to be funded by the STATE to provide fire protection services on a total of approximately 106,584 acres of State Responsibility Area within COUNTY'S SRA Protection Areas.
- B. COUNTY shall provide to STATE a plan of operations and organization for the COUNTY department contemplated hereunder on forms approved by the STATE, a copy of which is attached marked Exhibit G of this Agreement, which shall show that COUNTY organization is capable of meeting the requirements set forth in the "Gray Book."
- C. STATE shall jointly develop and annually review an Operating Plan with the COUNTY that will document those factors specific to that COUNTY. The factors may include specific dispatching procedures, pre-approved initial attack dispatch levels, agency fire protection organization, reimbursement criteria, and other elements agreed to by the STATE and the COUNTY.
- D. The STATE'S designated representative shall annually examine, on-the-ground with the COUNTY'S designated representative, the facilities and services the COUNTY has made available in order to ascertain whether the terms of the agreement have been met. Not withstanding the foregoing, COUNTY shall permit inspection, at any time by representatives of STATE, of crews, vehicles, property and other components of the organization established under the terms of this Agreement.
- E. Should the operations or organization of COUNTY, in reasonable judgment of the STATE, fail to meet the standard of protection required by this agreement, the STATE shall so inform COUNTY and take any reasonable action to maintain the required level of fire prevention and suppression capability.
- F. For the purpose of effecting mutual aid in times of fire emergency, either STATE or COUNTY may contribute without cost to the other, such persons and facilities as the contributing party may be willing and able to contribute, and which the receiving party may be willing to accept and direct; this provision shall not abrogate the terms and conditions specified in any other written agreement entered into by the parties hereto, for the specific purpose of exchanging fire control forces, either on a voluntary or upon a pay basis.
- G. Rewards as provided in Public Resources Code Section 4417, may be paid by STATE from funds not included in this contract upon recommendation of the Chief of the COUNTY'S department.
- H. COUNTY shall furnish adequate supervision for said fire protection through a qualified and duly appointed Chief Officer of the department providing services contemplated hereunder. When it becomes necessary to contract for the services of other entities to suppress a wildland fire on State Responsibility Area within COUNTY'S SRA Protection Areas, STATE agrees to accept its proportionate level of financial responsibility for those contracts and services required to protect State Responsibility Areas within COUNTY'S SRA Protection Areas, provided that the COUNTY obtains prior approval from STATE and exercises reasonable care and due diligence in the selection and the supervision of the contracting entities

- I. COUNTY shall submit, when required by the STATE, reports relating to fire occurrence and history, law enforcement, personnel status, and fire prevention activity.
- J. COUNTY shall annually appropriate and expend a sum not less than the amount established annually in the STATE'S Budget Act for said COUNTY for the purpose of preventing and suppressing forest fires as defined in Section 4103, of the Public Resources Code, on the designated State Responsibility Areas within COUNTY'S SRA Protection Areas during the term of this agreement.
- K. COUNTY shall comply with applicable rules and regulations for prescribed burning of wildlands as described in Sections 4461 to 4480, of Public Resources Code.

2. Emergency Operations

When COUNTY resources, equipment, and/or personnel are assigned to a State Responsibility Area wildland fire within COUNTY SRA Protection Area, costs over and above the "Gray Book" allotment may be reimbursed by STATE. Such reimbursements will be in accordance with the following provisions:

A. COUNTY may use and bill STATE for COUNTY funded engine companies, bulldozers, handcrews, aircraft, specialized equipment, and overhead personnel when used to protect STATE interests. Under certain conditions as outlined in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement, COUNTY may also bill STATE for STATE-funded COUNTY engine companies and bulldozers. These reimbursements to COUNTY will be from the STATE Emergency Fund and shall be in addition to the annual payment amount described in Exhibit B, Paragraph 1.A., of this Agreement.

The following conditions shall apply for reimbursement of COUNTY engine companies, bulldozers, aircraft, handcrews, and specialized equipment:

- 1) ENGINE COMPANIES
 - (a) STATE shall reimburse COUNTY for engine companies when used on a State Responsibility Area wildland fire within the COUNTY'S SRA Protection Areas in accordance with criteria for determining reimbursement eligibility as outlined in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.
 - (b) STATE shall reimburse COUNTY for engine companies that provide move-up and cover to STATE-funded COUNTY stations within the COUNTY when such cover assignments are the result of a State Responsibility Area wildland fire within COUNTY'S SRA Protection Areas. Specific conditions for approval of move-up and cover assignments shall be outlined in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.
 - (c) Reimbursement of COUNTY engine companies shall be based on COUNTY rates on file with STATE at time of initial dispatch.

(d) County engines billed to STATE must be identified by an incident order and request number and the associated cost; such costs shall be limited to engine, officer, operator, and crew.

2) BULLDOZERS

- (a) STATE shall reimburse COUNTY for COUNTY bulldozers when used on a State Responsibility Area wildland fire within COUNTY'S SRA Protection Areas in accordance with criteria for determining reimbursement eligibility as outlined in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.
- (b) Payment of County bulldozers, transports, and operators shall be based on COUNTY operating rates on file with STATE at time of initial dispatch.
- (c) County bulldozers billed to STATE must be identified by an incident order and request number and the associated cost; such costs shall be limited to dozer transport and operator, and dozer and operator.
- (d) COUNTY shall provide STATE a list of bulldozers, size, model, and identification number, which shall be subject to this agreement. These shall be included in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.

3) AIRCRAFT

- (a) STATE shall reimburse COUNTY for COUNTY aircraft when used on a State Responsibility Area wildland fire within COUNTY SRA Protection Areas in accordance with criteria for determining reimbursement eligibility as outlined in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.
- (b) Reimbursement of COUNTY aircraft shall be based on COUNTY operating rates on file with STATE at time of initial dispatch.
- (c) STATE shall pay aircraft pilots at COUNTY rate.
- (d) STATE shall pay for one air tactical officer accompanying a COUNTY fixed-wing aircraft and one crew member assigned to each COUNTY helicopter at the COUNTY rate.
- (e) COUNTY aircraft billed to STATE must be identified by an incident order and request number and the associated cost.
- (f) COUNTY shall provide STATE a list of aircraft by make, model and aircraft identification number, which shall be subject to this agreement. These shall be included in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.

4) SPECIALIZED EQUIPMENT

- (a) STATE shall reimburse COUNTY for COUNTY specialized equipment when used on a State Responsibility Area wildland fire within COUNTY SRA Protection Areas—in accordance with criteria for determining reimbursement eligibility as outlined in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.
- (b) For the purpose of this Agreement, Specialized Equipment shall include but is not limited to dozer tenders, helitenders, water tenders, communications units, and mobile kitchens or food service units. Other kinds of specialized equipment may be eligible for reimbursement if authorized by STATE.
- (c) Reimbursement of COUNTY specialized equipment shall be based on COUNTY operating rates on file with STATE at time of initial dispatch.
- (d) COUNTY specialized equipment billed to STATE must be identified by an incident order and request number and the associated cost; such cost shall be limited to the cost of the equipment usage and equipment operator.
- 5) HAND CREWS
 - (a) STATE shall reimburse COUNTY for COUNTY hand crews when used on a State Responsibility Area wildland fire within COUNTY'S SRA Protection Areas in accordance with criteria for determining reimbursement eligibility as outlined in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.
 - (b) When the California Department of Corrections and Rehabilitation or other State Agency pays the base salary of a hand crew, including COUNTY fire department supervisors, correctional officers and inmates, then STATE shall only pay those costs which exceed the basic salary of the crew (e.g. overtime and incidental operating expenses) accrued on the emergency.
 - (c) The STATE shall pay only for additional COUNTY personnel needed as crew strike team leaders to a limit of one strike team leader per crew strike team as defined in Incident Command System (ICS) standards for a crew strike team and for one technical specialist-crews per incident.

OVERHEAD PERSONNEL

- (a) STATE shall reimburse COUNTY for COUNTY overhead personnel when used on a State Responsibility Area wildland fire within the COUNTY'S SRA Protection Areas in accordance with criteria for determining reimbursement eligibility as outlined in the State/County Operating Plan described in Exhibit A, Paragraph .1.B. and 1.C., of this Agreement.
- (b) Reimbursement of COUNTY Overhead Personnel shall be based on COUNTY rates on file with STATE at the time initial dispatch.

B. NOTIFICATION

- 1) Whenever COUNTY expects payment for services under the provisions of this paragraph, COUNTY must notify STATE of the commitment of any of these resources that have been pre-approved for use as an element of initial attack and so documented in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement. This notification must occur in a timely manner so that an appropriate audit trail can be established.
- 2) For those resources employed after initial attack, notification will occur when the request for approval of use is made to STATE.
- C. STATE shall reimburse COUNTY for COUNTY resources (equipment and personnel) when ordered by STATE or COUNTY in support of a special staffing pattern in accordance with conditions for approval of a special staffing pattern as outlined in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.

3. Assistance for Hire

- A. COUNTY resources (equipment and personnel) requested directly by STATE for an out-ofcounty assignment will be reimbursed as Assistance-for-Hire for actual costs incurred by COUNTY.
- B. For any State Responsibility Area wildland fire where costs are incurred pursuant to the terms of this AGREEMENT, STATE and COUNTY will comply with the processes and procedures for incident billing established in the STATE/COUNTY Operating Plan described in Exhibit A, Paragraph 1.B. and 1.C., of this Agreement.

Invoicing and Payment Provisions

1.

- 1. For services satisfactorily rendered, and upon receipt and approval of the invoices, the STATE shall annually pay to COUNTY that amount which is set forth in the STATE'S budget for each fiscal year involved as the STATE'S contribution to the support of the organization maintained by COUNTY for the prevention and suppression of wildland fires on lands described herein. The total amount payable by STATE to COUNTY for Gray Book-County Budget Detail (Gray Book) shall not exceed the amount specified on STANDARD FORM 213, Item 3, during the term of this agreement. This amount shall not include payments to the COUNTY for COUNTY resources used to suppress state responsibility fires under conditions set forth in Exhibit A, Paragraphs 2, A, 1) through 6) of this Agreement.
- 2. COUNTY shall request payment in an amount not to exceed the sum designated in paragraph A above in the manner described hereinafter.
- 3. COUNTY shall prepare and submit "Gray Book" invoices to STATE monthly, quarterly, semiannually, or annually at COUNTY'S option, in arrears after STATE has certified that such services have been satisfactorily provided in accordance with this Agreement, during the period covered by said invoice. The final statement for any fiscal year covered by this Agreement shall be submitted no later than sixty days following the end of that fiscal year. "Gray Book" invoices shall include the Agreement Number and shall be submitted in triplicate in arrears to:

4. In the event that the STATE during the term of this Agreement increases salary, augments staffing, or other expense items, having the effect of increasing such cost, the "Gray Book" may be amended to reflect such increase provided that funds have been appropriated and are available for such purpose. Similarly, in the event that the STATE receives a budget reduction having the effect of decreasing such cost, the "Gray Book" may be amended to reflect such decrease. In the event no appropriation is made for the purpose of this Agreement, the obligations of the parties to each other under this Agreement shall cease and this Agreement shall become null and void.

2. Budget Contingency Clause

- A. It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of this Agreement.
- B. If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, the State shall have the option to either cancel this Agreement with no liability occurring to the State, or offer an agreement amendment to Contractor to reflect the reduced amount.

3. Prompt Payment Clause

Upon receipt of a properly submitted, undisputed invoice, STATE shall pay COUNTY within forty-five (45) days, or automatically calculate and pay the appropriate late payment penalties as specified in Government Code, Chapter 4.5, Section 927. In the event of an emergency, as defined in Section 927.11, late payment penalties may not apply. Specific to STATE, if an invoice from a business under contract with STATE becomes subject to late payment penalties during the annually declared fire season, then the required payment approval date shall extend 30 calendar days beyond the initial 45-day period. The total shall include the current applicable CAL FIRE Administrative Rate

EXHIBIT D (Special Terms and Conditions)

1. Excise Tax

The State of California is exempt from federal excise taxes, and no payment will be made for any taxes levied on employees' wages. STATE will pay for any applicable State of California or local sales or use taxes on the services rendered or equipment or parts supplied pursuant to this Agreement. California may pay any applicable sales and use tax imposed by another state.

2. Settlement of Disputes

In the event of a dispute, within ten (10) days of discovery of the problem contractor shall file a "Notice of Dispute" with:

California Department of Forestry and Fire Protection (CAL FIRE) Attention: Contracts Manager P.O. Box 944246 Sacramento, CA 94244-2460

Within ten (10) days of STATE receiving contractor's notice, the contracts manager or designee shall advise contractor of the findings and recommend a method to resolve the dispute. Decision of the contracts manager or designee shall be final.

In the event of a dispute, the language contained within this Agreement shall prevail over any other language including that of the bid proposal.

3. Right to Terminate

Either party may terminate this Agreement at any time by giving a minimum of 12 months notice to the other party. In the event of termination, STATE shall pay Contractor for all costs and un-cancelable obligations incurred to the date of termination up to but not exceeding the maximum amount payable.

4. Potential Subcontractors

Nothing contained in this Agreement or otherwise, shall create any contractual relation between the STATE and any subcontractors, and no subcontract shall relieve the Contractor of his responsibilities and obligations hereunder. The Contractor agrees to be as fully responsible to the STATE for the acts and omissions of its subcontractors and of persons either directly or indirectly employed by any of them as it is for the acts and omissions of persons directly employed by the Contractor. The Contractor's obligation to pay its subcontractors is an independent obligation from the STATE'S obligation to make payments to the Contractor. As a result, the STATE shall have no obligation to pay or to enforce the payment of any moneys to any subcontractor.

5. Evaluation of Contractor

Performance of the Contractor under this Agreement will be evaluated. The evaluation shall be prepared on Contract/Contractor Evaluation Sheet Sheet (STD 4), and maintained in the Agreement file. For consultant agreements, a copy of the evaluation will be sent to DGS, Office of Legal Services, if it is negative and over \$5,000.

EXHIBIT D (Special Terms and Conditions)

6. Agency Liability

The Contractor warrants by execution of this Agreement, that no person or selling agency has been employed or retained to solicit or secure this Agreement upon agreement or understanding for a commission, percentage, brokerage, or contingent fee, excepting bona fide employees or bona fide established commercial or selling agencies maintained by the Contractor for the purpose of securing business. For breach or violation of this warranty, the STATE shall, in addition to other remedies provided by law, have the right to annul this Agreement without liability, paying only for the value of the work actually performed, or otherwise recover the full amount of such commission, percentage, brokerage, or contingent fee.

7. Force Majeure

Neither party shall be liable to the other for any delay in or failure of performance, nor shall any such delay in or failures of performance constitute default, if such delay or failure is caused by "Force Majeure." As used in this section, "Force Majeure" is defined as follows: Acts of war and acts of God such as earthquakes, floods, and other natural disasters such that performance is impossible.

8. Contractor Name Change

Contractor shall provide a written notice to the STATE at least thirty (30) days prior to any changes to the Contractor's current legal name.

EXHIBIT E (Standard Agreement)

ADDITIONAL PROVISIONS

1. Holding Over

- A. In the event STATE or COUNTY decides not to renew this Agreement, STATE or COUNTY shall provide the other a minimum of 12 months written notice of such intention. If no such notice is received, and a new Agreement has not been executed, this Agreement shall be automatically extended on the same terms and conditions as contained herein, together with amendments if any, until the earlier of:
 - 1. The date on which a new renewal Agreement is fully executed, or
 - 2. Termination of this holdover Agreement by the mailing by either COUNTY or STATE of 12 months written notice to the other party.
- B. Renewal Agreements shall be retroactive to the end of the term of the present Agreement. Any payments made during a holdover period shall, if necessary, be promptly adjusted to comply with payments called for in the new Agreement. Such adjustments shall occur within 60 days after approval of the new Agreement by DGS. COUNTY shall invoice STATE for any billing correction made necessary because of changes in the contract rates.
- C. The effectiveness of this Exhibit E, Paragraph 4, is conditional upon the lawful appropriation and availability of STATE funding for COUNTY'S services during the term of this Agreement.

2. Indemnification

Paragraph 5 of Exhibit C, General Terms and Conditions, does not apply because it is superseded by this Paragraph.

COUNTY agrees to indemnify, defend and hold harmless the State, its officers, agents and employees from any and all claims and losses accruing or resulting to any person, firm or corporation who may be injured or damaged by COUNTY in the performance of this Agreement.

Pursuant to Government Code Section 925 et seq., STATE agrees to indemnify, defend and hold harmless the COUNTY, its officers, agents and employees from any and all claims and losses accruing or resulting to any person, firm or corporation who may be injured or damaged by STATE in the performance of this Agreement.

3. Indemnification for Vegetation Management Projects

The STATE agrees to indemnify, defend, and hold harmless the COUNTY, its agents, officers and employees, from and against any and all liability expense, including defense costs and legal fees, and claims for damages of any nature whatsoever, arising solely out of performance by the COUNTY of approved vegetation management projects undertaken as part of fire prevention activities under this Agreement.

- 4. Notwithstanding the terminology of Public Resources Code Sections 4119, 4153, 4423, and 4436, the COUNTY shall not act as an agent of the STATE but shall exercise the powers granted in those sections independently as authorized by Public Resources Code Section 4129.
- 5. Paragraph 15 of Exhibit C, does not apply to this Agreement because the services provided in this Agreement were not obtained by means of a competitive bid.

ASSIGNMENT OF STATE FIRE PROTECTION AGREEMENT

This Assignment is made and entered into on the date approved by the Board of Supervisors or when fully executed by the parties, whichever occurs later, and is by and between the County of Orange, a political subdivision of the State of California, hereinafter referred to as "County," and the Orange County Fire Authority, hereinafter referred to as "Authority," with County and the Authority sometimes referred to as "Party," or collectively as "Parties."

WHEREAS, the Orange County Fire Authority, a joint powers authority, was formed as of March 1, 1995, between the County of Orange (County) and various cities in Orange County for the provision of fire services; and

WHEREAS, pursuant to Public Resources Code sections 4129 and 4133, the State of California Department of Forestry and Fire Protection (State) may contract with counties to provide fire protection services in State Responsibility Areas (SRAs) within a county, but the State is not authorized to contract directly with the Orange County Fire Authority for such services; and

WHEREAS, State and County entered into Agreement No. 7CA _____ on ____, 2017; and

WHEREAS, State and County are entering into Agreement (Agreement) for wildland fire protection services in SRAs within the county; and

WHEREAS, the parties desire that the Agreement be assigned to the Orange County Fire Authority, and the State concurs with the assignment.

NOW, THEREFORE, the Parties mutually agree as follows:

- 1. County hereby delegates to Authority the duty to perform all obligations specified in the Agreement and the plans and operating procedures for administering said Agreement. County hereby assigns to Authority all of its rights under the Agreement, including the right of County to request and receive payment and reimbursement directly from State for any services provided under the Agreement. Authority hereby accepts the foregoing delegation and assignment.
- 2. Authority agrees to honor the terms and conditions of the Agreement and the plans and operating procedures for administering the Agreement.
- 3. Pursuant to Public Resources Code section 4135, the money paid by State under the Agreement shall be expended for fire protection and suppression.
- 4. Authority agrees to indemnify, defend with counsel approved in writing by County, and hold County, its elected and appointed officials, officers, employees, agents and those special districts and agencies which County's Board of Supervisors acts as the governing Board harmless from any claims, demands or liability of any kind or nature, including but not limited to personal injury or property damage, arising from or related to Authority's performance under the Agreement. Provided, however, that nothing in this Assignment waives or limits any immunities Authority may have with respect to claims made by third parties.

Summary

This item is submitted for approval to carryover funding for one-time projects and grant-funded projects that were not completed prior to year-end in FY 2016/17 and require a rebudget to FY 2017/18. This request also includes a first quarter budget adjustment to appropriate funding for three projects funded by CAL FIRE, which have become necessary since budget approval.

Prior Board/Committee Action

Not Applicable.

RECOMMENDED ACTION(S)

To carryover funding for one-time projects and grant-funded projects that were not completed prior to year-end in FY 2016/17 and require a rebudget to FY 2017/18, it is recommended that the Board authorize the following proposed budget adjustments:

- 1. Approve a budget adjustment in the General Fund (121) increasing revenues by \$520,739 and expenditures by \$2,373,116.
- 2. Approve a budget adjustment in the General Fund CIP (12110) increasing expenditures by \$1,288,881.
- 3. Approve a budget adjustment in the Fire Stations and Facilities Fund (123) increasing expenditures by \$7,814,115.
- 4. Approve a budget adjustment in the Communications and Information Systems Fund (124) increasing expenditures by \$1,885,180.
- 5. Approve a budget adjustment in the Fire Apparatus Fund (133) increasing expenditures by \$1,377,240.
- 6. Approve a budget adjustment in the Structural Fire Entitlement Fund (171) increasing expenditures by \$549,651.
- 7. Approve a budget adjustment transferring \$2,100,000 from the General Fund (121) to the General Fund CIP (12110) to ensure sufficient fund balance in the fund to complete the projects.

Impact to Cities/County

The proposed adjustments to the FY 2017/18 budget will have no impact to cash contract city charges.

Fiscal Impact

Approval of the requested Carryover adjustments will increase revenues and appropriations in the funds listed commensurate with the equivalent amounts of unexpended fund balance from FY 2016/17. The First Quarter Budget Adjustment will increase expenditures in the General Fund (121) by \$246,140, and by \$100,000 in the Fire Stations and Facilities (123) Fund.

Background

The annual carryover request includes projects in the General and Capital Improvement Program (CIP) funds as summarized on Attachment 1. Due to the complexity and size of some of the projects and the time required to complete others, not all projects were completed in FY 2016/17; therefore, staff is recommending appropriations for these projects be carried over to FY 2017/18, so the projects can be completed. Carryover requests reflect simply a timing change of planned expenditures.

The first quarter budget adjustment includes three CAL FIRE funded projects which have become necessary after the budget was adopted in May. Those requests are detailed on Attachment 2.

Summary

This agenda item seeks approval of actions to continue addressing the impacts associated with extraordinary forced hiring of firefighter personnel.

Prior Board/Committee Action

On July 27, 2017, the Board of Directors approved several actions to assist staff in addressing the high volume of forced hiring, improving firefighter staffing, and beginning to mitigate the associated negative impacts to personnel. In seeking approval of those actions, staff stated its intent to continue seeking methods to mitigate negative staffing impacts.

RECOMMENDED ACTION(S)

The recommended actions will continue addressing the impacts associated with extraordinary forced hiring of firefighter personnel.

- 1. Establish a 7.5% specialty pay for 24 designated manpower coordinators at Fire Stations 22 (Laguna Hills) and 64 (Westminster).
- 2. Increase appropriations in the FY 2017/18 General Fund (121) Budget by \$200,147 to fund the specialty pay.

Impact to Cities/County

Not Applicable.

Fiscal Impact

The cost increase to the FY 2017/18 budget associated with the specialty pay for the remainder of the fiscal year is \$200,147. The ongoing annual cost for future years is \$266,863.

Background

A collaborative workgroup comprised of subject matter experts, labor representatives, and management (Joint-Labor-Management Group [JLM]) began meeting in May 2017 to discuss issues that are causing an extraordinary volume of forced hiring activity in the firefighter ranks. To date, the JLM has identified several actions to begin addressing the root causes of the extraordinary forces and to mitigate the negative impacts. Attached is the staff report that the Board approved in July 2017 describing the problem in detail and beginning to implement solutions. The JLM is committed to continuing its efforts to further refine staffing procedures, enhancing systems, and putting processes in place that should prevent these negative impacts from recurring in the future.

One of the recommended actions is to establish two designated staffing fire stations and to assign responsibility to personnel at those stations to handle all manpower staffing needs for the OCFA. In the past, the OCFA has tried differing structures for handling manpower needs:

- Following the OCFA formation, the Authority had full-time administrative employees who were assigned responsibility for coordinating manpower; however, because staffing needs and issues would arise 24 hours per day, 7 days per week, the regular 40-hour work schedule for the manpower employees was found to be ineffective. As a result, manpower coordination was transitioned to personnel in the field for 24/7 coverage.
- When manpower coordination was transitioned to the field, numerous personnel serving in each of OCFA's nine battalions were assigned the staffing responsibilities; however, too many employees involved in the process resulted in inconsistent interpretation of policies, duplication of efforts, and difficulty coordinating the tasks being performed. Further compounding the inefficient structure is the fact that the OCFA's staffing issues have become more complex since overtime requirements to fill constant staffing is exceeding personnel's desires to volunteer and work the necessary overtime.

The manpower coordinators are responsible for contacting personnel who have already worked all their required shifts and informing them that they are being forced to work another shift. Often, these forces can cause personnel to miss other plans, appointments, and/or commitments, negatively impacting the employee's work-family-life balance. The manpower coordinators must perform this work to ensure that the OCFA is staffed 24/7 and ready to serve the public.

Changing the structure for manpower coordinators from nine battalions to two designated staffing stations will improve consistency, coordination, and eliminate duplication of effort, while still providing necessary redundancy. At the same time, the workload burden for the designated personnel will increase. The new structure will designate Fire Stations 22 (Laguna Beach) and 64 (Westminster) as the "staffing stations," which provides one station in the north end of the county and one in the south end of the county. The four personnel assigned to staff the Truck at each of these stations (eight personnel, with three shifts, for a total of 24 total impacted employees) will be assigned the duties of manpower coordinators.

To address the increased workload proposed for manpower coordinators and recognizing the challenges associated with the work, the JLM is recommending specialty pay for these manpower coordinators at 7.5% of top-step firefighter salary. Personnel transferring into these designated positions will be required to complete a Manpower Coordinator Training Program to demonstrate competencies in administering the system to be eligible for the specialty pay. Because of these actions, we anticipate that the "two designated staffing station" structure will yield well-trained employees who are engaged in effective administration of OCFA's manpower needs.

Following implementation of this recommendation, the OCFA will be better prepared to provide the highest level of emergency, fire, rescue, and emergency medical services, with consistent handling of manpower needs. With the Board of Directors' approval, these recommendations are anticipated to take effect Friday, September 29, 2017.

Summary

This agenda item seeks approval of actions to reduce overtime and the extraordinary volume of forced hiring activity that has been occurring in the firefighter ranks.

Prior Board/Committee Action

Not applicable.

RECOMMENDED ACTION(S)

These actions are needed to reduce overtime and the extraordinary volume of forced hiring activity that has been occurring in the firefighter ranks:

- 1. Direct staff to convert funding for 53 existing positions (17 Fire Captains, 15 Fire Apparatus Engineers, and 21 Firefighters) from overtime-funded to full-time salary and benefit-authorized positions, by taking the following actions:
 - a. Restore and activate 42 existing frozen positions on the Master Position Control (15 Fire Captains, 15 Fire Apparatus Engineers, and 12 Firefighters).
 - b. Add two Fire Captains (one regular position and one limited-term/grant-funded position) and 9 Firefighters as authorized positions to the Master Position Control.
- 2. Increase appropriations in the FY 2017/18 General Fund (121) Budget by \$345,191 to fund the difference between current budgeted overtime pay and regular salary and benefit costs for these converted positions.
- 3. Authorize staff to temporarily exceed the number of authorized firefighter positions on the Master Position Control to enable the hiring of 50 firefighters into each of the next two academies. This temporary authorization shall only apply to the next two academies (45 and 46), pending attrition/promotions that will occur during and following academy graduations.

Impact to Cities/County

The conversion of overtime-funded positions will enable OCFA to maximize the number of firefighters hired into the next two academies, which will allow vacant positions to be filled through regular work schedules and reduce overtime that existing firefighters are being forced to work. There will be no increase to Cash Contract city charges as a result of this change.

Fiscal Impact

An expenditure increase of \$345,191 is requested in the FY 2017/18 General Fund Budget. In addition, a mid-year budget adjustment may be necessary to reverse the salary savings that was deducted from the FY 2017/18 Salary and Employee Benefits budget since the budget figures estimated an average of 40 vacant firefighter positions during the fiscal year.

Background

Factors Driving Volume of Overtime & Forced Hiring of Firefighters

The OCFA maintains constant staffing levels, which means that every day, all authorized Operations post-positions are staffed. Constant staffing enables delivery of emergency services 24-hours per day, 7 days per week. A post-position is a seat on a fire or EMS response unit (including engines, trucks, and paramedic vehicles) that must be filled to meet the staffing requirements of that unit.

- Backfill occurs when there is a vacancy in a position that requires constant staffing and another employee works overtime to fill the vacancy. Examples include:
 - Positions are temporarily vacant due to personnel on sick leave, vacation, jury duty, military leave, bereavement, workers' compensation, etc.
 - Positions are temporarily vacant due to personnel assigned to paramedic school or assigned to a cadre to teach an academy
 - o Positions are vacant due to cost control measures (frozen positions per the MOU)
 - Positions are vacant as a result of retirements, promotions, the addition of new positions to staff a new station, or converting Basic Life Support engines to Advance Life Support
 - Positions are temporarily vacant due to personnel responding to major in/out of county emergency incidents
- Overtime is used for work performed above and beyond the constant staffing requirements. Examples of overtime include strike team or overhead personnel assignments for emergency incidents, either in or out of County, and mandatory training classes that occur on a day other than the employee's regularly assigned shift.

Daily Staffed Frozen Positions - Funded by Overtime

The OCFA has been carrying many frozen positions in the firefighter ranks on the Master Position Control for several years, primarily implemented as a cost-saving measure to balance the budget during the financial downturn starting in FY 2009/10. As reported to the Board each year in our Annual Overtime & Employee Compensation report, the use of backfill/overtime to fill the vacancies created by these frozen positions can produce savings since overtime hours are not "pensionable", meaning they don't result in additional pension earnings for those working the overtime, nor do they require retirement contributions as a percent of pay.

However, lower-cost retirement benefits are now being earned by new firefighters under the Public Employee Pension Reform Act (PEPRA), and these firefighters are paying their full employee-share of retirement costs; therefore, the savings differential from using overtime vs. full-time salary and benefit employees is diminishing. Furthermore, <u>the volume of overtime hours being demanded of our firefighters has become much greater than the hours they wish to work, resulting in an extraordinary amount of forced hiring activity for all firefighter ranks.</u>

Up until now, OCFA has been completing multiple academies and promotional processes per year to fill the vacancies that were occurring, over and above the frozen/overtime-funded positions. We are now reaching a point where the remaining vacancies that need to be filled include these constant-staffed overtime-funded positions, which are frozen on the Master Position Control (meaning we are unable to hire new employees into them). Staff believes the timing is appropriate to complete a transition whereby the overtime-funded positions are converted to regular authorized salary and benefit positions.

Actions to Reduce Overtime & Forced Hiring Activity

Executive management has been meeting with representatives of the Orange County Professional Firefighters Association (OCPFA) to identify actions to reduce the extraordinary amount of

overtime and forced hiring activity. Actions that the joint labor-management (JLM) group have agreed upon include:

- Implement earlier start-dates for the next two firefighter academies (September 2017 and February 2018 instead of October 2017 and March 2018)
- Maximize the number of firefighters hired into each of the next two academies, with a goal of hiring 50 firefighters for each academy
- Implement a continuous open recruitment process
- Develop multiple entry portals for new OCFA firefighters (entry level firefighter, entry level firefighter/paramedic, lateral firefighter/paramedic)
- Balance the timing of promotions into Engineer and Captain ranks in a manner that works in harmony with the timing of Firefighter Academy graduations
- Utilize multiple communication methods with candidates during recruitment processes
- Make multiple programming changes in the automated Staffing System to enable employees to enter a greater variety of "availabilities," which will facilitate voluntary coverage of shifts that require overtime/backfill instead of forcing employees to work overtime
- Implement methods to encourage/incentivize employees to enter "availabilities" to cover shifts that require overtime/backfill

The JLM group will continue meeting to sustain progress on the variety of initiatives already agreed upon, monitor the effectiveness of the initiatives as they are completed, and continue seeking new and better methods to minimize negative staffing impacts.

Financial Impact of Recommended Actions

A key part of implementing the initiative to maximize the number of firefighters hired into each of the next two academies involves a change in the structure of the frozen positions OCFA has been carrying and filling with overtime (as discussed above). Converting these frozen positions from overtime-funded to regular full-time salary and benefit positions is required. Although there is an ongoing cost to make the conversion, staff believes that the net financial impact of this change is a worthy investment to achieve the goal of reducing overtime and forced-hiring activity.

The matrix below identifies the anticipated reduction in overtime costs and the corresponding increase in regular salary and benefit costs associated with converting the proposed 53 positions. The partial-year impact anticipated in FY 2017/18 will be offset by a one-time budget reduction due to a later start-date for expanded Fire Station 20 staffing, compared to the timeline that we anticipated when the budget was developed.

The net financial impact of the proposed changes during FY 2017/18 is an increase in expenditures of \$345,191. Once all hiring and promotional activities are complete for these converted positions, we anticipate that annual overtime costs will be reduced by \$9.1 million.

DESCRIPTION:

CLASS SUMMARY:

Incumbent is responsible for performing executive level activities. Incumbent is responsible for planning, organizing, and directing the operation of the Orange County Fire Authority (OCFA) and to act at the direction of the OCFA Board of Directors.

DISTINGUISHING CHARACTERISTICS:

The Fire Chief is the third level in a three level executive management series. The Fire Chief is distinguished from the Deputy Fire Chief, which has responsibility for assisting the Fire Chief in organizing and directing the operation of the OCFA.

ESSENTIAL FUNCTIONS:

(These duties are intended to be representative sample of the duties performed by the class.)

Confers with and directs the day-to-day activities of the OCFA through the Deputy Fire Chief; directs his training and development and evaluates his performance.

Plans, implements, and directs all phases of the operations of the Authority; formulates departmental operating policy in conformance with Board of Directors' policy and legislative mandate.

Develops and recommends departmental goals and objectives and delegates authority and responsibility to meet the goals and objectives; evaluates and reports to the Board of Directors on the effectiveness and efficiency of departmental operations.

Establishes the implementation of OCFA standard operating procedures and ensuring compliance with Federal, State, and local laws.

Reviews management staff recommendations for staff and equipment; recommends departmental budget priorities; presents and justifies program and budget recommendations for the Board of Directors.

Coordinates with contiguous fire departments and develops mutual assistance programs where appropriate.

Meets with citizen groups to discuss and explain the various OCFA all-risk injury prevention and life safety programs; promotes community support of the Authority programs. Evaluates community needs; recommends modification of departmental operations to meet new or changed needs.

Works closely with the City Manager's Technical Advisory Committee, three standing committees of the Board of Directors, as well as special ad hoc committees as needed.

Performs other duties of a similar nature or level.

MINIMUM QUALIFICATIONS:

EDUCATION AND EXPERIENCE (*position requirements at entry*):

Bachelor's Degree in Public Administration, Business Administration, or a related field. Ten (10) or more years of progressively responsible divisional or departmental management experience, including labor relations, meet and confer with employee groups, and grievance resolution. Up to four years of job-related experience can be substituted for up to two years of the education requirement for this position; or, an equivalent combination of education and experience sufficient to successfully perform the essential duties of the job such as those listed above.

Desirable: Additional college-level or coursework above the Bachelor's Degree level. Enrollment in the National Fire Academy Executive Fire Officer Program; Public Administration, Fire Protection Administration or related field; qualified under the National Wildfire Coordinating Group guidelines, in one or more Incident Command System Section Chief positions.

LICENSES AND CERTIFICATIONS (position requirements at entry):

Possession of or ability to obtain a valid California Driver License, Class C or higher, before date of appointment, may be required. This classification is subject to enrollment in the California DMV Pull Notice Program, which periodically provides Risk Management with the incumbent's Driver License record and status.

KNOWLEDGE (position requirements at entry):

Knowledge of:

• Contemporary leadership principles and practices applicable to a modern, decentralized, service-oriented organization;

• Management principles and practices necessary to plan, analyze, develop, direct, and evaluate regional programs, administrative policies, organizational structures, and the various OCFA all-risk injury and life safety practices;

• Principles and processes necessary to accomplish organizational change in a highly traditional and unionized work environment;

• Principles and modern methods of fire suppression/prevention;

• Administration principles and practices including organization, fiscal management,

budgetary preparation and controls, program planning, implementation, and administration; local government funding regulations and processes including fee for service, property tax regulation and cost recovery;

• Federal and State laws, rules, and procedures governing fire suppression, prevention, and investigation;

• Principles of employee supervision and personnel management including labor relations, training, disciplining of personnel, and modern information systems.
