General Counsel David Kendig read into record a summary of the Fire Chief contract's salary and benefits.

On motion of Director Swift and second by Director Hernandez, the Board of Directors voted by those present following the Closed Session negotiation of agreement terms, to approve an employment agreement for the Fire Chief.

Directors Basile, Bartlett, Gamble, and Spitzer, while noting their support for the appointment of the new Fire Chief, voted in opposition to the employment agreement.

Director Shawver requested adding an agenda item to a future Board of Directors meeting regarding economic impacts of Public Records Act requests on the OCFA.

Newly appointed Fire Chief Brian Fennessy extended thanks to the Board, labor groups, staff, and Interim Fire Chief McIntosh for their support and the honor to serve OCFA.
